

FUSIONZ NETWORK ADDRESSES THREE CRITICAL CHALLENGES:



- Severe data silos across blockchains and enterprises
- Imbalanced compute demand dominated by tech giants
- Lack of unified standards for data-compute collaboration

FZX creates a decentralized marketplace for data and compute power through cross-chain protocols and edge scheduling

INDUSTRY & OPPORTUNITIES

- Al boom: By 2030, Al market projected to exceed \$1.8 trillion, but compute power remains centralized.
- Blockchain data growth: 300+ public chains worldwide, urgent need for cross-chain integration.
- Edge computing: Market to exceed \$100B by 2027, but integration with Web3 remains weak




FZX positions itself at the intersection of AI, Web3, and edge compute


TECHNOLOGY ARCHITECTURE

- CrossChain DataHub: Decentralized oracles + indexing ensure verifiable data.

- ZK-Privacy Engine: Zero-knowledge proofs protect privacy & compliance.
- FZX Tokenomics: Powers transactions, rentals, governance, and incentives






